As you know, I am counsel to the Receiver, Beattie B. Ashmore, in the above referenced matter. Mr. Ashmore was appointed as the Receiver for Scott A. Kohn (“Kohn”), Future Income Payments, LLC (“FIP”) and other related entities collectively referred to as the FIP Receivership Entities by the United States District Court for the District of South Carolina in an order amended most recently on July 18, 2019 (“Order”). 2. For the period after Melanie Jo Schultz-Miller was terminated by Shurwest, LLC (May 2018 to present), please provide all email or other correspondence related to Future Income Payments, LLC, Scott Kohn, or any Receivership Entity, including but not limited to all emails


where Melanie Jo Schultz-Miller or her company MSJM Financial, LLC was a recipient or author of the email.
